RELEASE OF LIABILITY FOR MINOR PARTICIPANTS (2024)

READ BEFORE SIGNING

IN CONSIDERATION OF my child(ren) being allowed to Name of Minor Child(ren) participate in any way in any and/or all events and/or activities sanctioned by, or related to, the Suburban Swim Association of South Jersey (SSASJ) during calendar year 2024, the undersigned acknowledges, appreciates, and agrees that:

The risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19) to my child from the activities involved in these programs are significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and,

1. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation; and,
2. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in the program itself, I will remove my child from the participation and bring such attention of the nearest official immediately; and,
3. I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS the SSASJ; its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property incident to my child's involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
4. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.
5. I, the parent/guardian, assert that I have explained to my child(ren): the risks of the activity, his/her responsibilities for adhering to the rules and regulations, and that my child(ren) understands this agreement.

Code of Conduct for Coaches, Swimmers, and Parents/Guardians

1. We are one unified team in a competitive swim league. No matter a swimmer's age, gender, and/or swimming ability we are all teammates and will exhibit good sportsmanship.
2. We will refrain from judging, criticizing, or gossiping about each other. We will not discuss individuals when not in our presence.
3. We will treat all members of the team (coaches, swimmers, parents, officials) and opponents with dignity and respect. We understand that physically or verbally abusive behavior to anyone is unacceptable and may damage our team.
4. We will be dedicated and loyal to our club and teammates. We will be vocally supportive.
5. We will "praise in public and correct in private".
6. We will display our team pride by competing and personal appearance shall be neat, clean, and appropriate. Team swim caps and royal blue swimsuits must be worn when competing. Be proud to wear your Stingray colors!
7. We are encouraged to participate in all team activities, practices, and swim meets and we are expected to stay in the designated team area(s) at all swim meets.
8. We will arrive to practices, swim meets, and team events allowing enough time to begin on time. We will be prepared and have our swim cap, goggles, towel and refreshments/snacks ready.
9. We will be committed to putting forth our best effort every day. An honest and best effort does not include cutting laps, hanging/pulling on the lane lines, missing practices, and/or missing swim meets and team events.
10. We are all responsible for the care and proper use of swim team and Hammonton Swim Club equipment and facilities, as well as for such equipment and facilities when visiting other swim clubs for swim meets. Practice is not finished until all practice supplies are returned to the storage shed and lane lines are removed from the pool and properly stored. We are all responsible for cleaning up after ourselves, as well as after practice sessions and swim meets (this includes picking up trash, water bottles, arranging chairs and tables, etc.). Everyone helps!
11. We will check the swim team bulletin board and our mailbox each day of practice and during swim meets.
12. We will give the head coach at least 48-hours advance notice if unable to attend a swim meet. Preparation of the swim meet sheet and line-up(s) begins two-days prior to a swim meet and not showing up for a swim meet without notifying the head coach well in advance can hurt the team and other swimmers and it may create additional work for the coach(es).
13. We will refrain from using drugs, alcohol, tobacco, e-cigarettes/vaping and/or any other product(s) detrimental to our health and/or inappropriate for minors.

Failure to comply with the Code of Code may result in disciplinary action. Such discipline may include, but may not be limited to, the following:

- *Dismissal from a practice session and/or swim meet and asked to leave the swim club facilities/property;*
- *Disqualification from one or more swim meet events, or suspension from an entire swim meet;*
- *Dismissal from the swim team.*
